I think your boss would need to be prepared not to freelance on tougher questions outside his ambit – i.e. the mechanics of the negotiations, finance stuff, loss & damage, etc. I doubt these reporters would ask about those, but I do worry that – given the total non-presence of high-visibility U.S. administration officials at the COP - subnational leaders will sometimes serve as stand-ins (in those roles) for reporters at the COP, and the tough questioning that usually follows.
