As a follow-up to my email below, as well as our meeting with Seth Platt, please be advised that the New York v. BP, Chevron, et al. case, which Seth had provided to us for our meeting, was just dismissed by the United States District Court in New York on July 19 (see attached Order), for almost the identical reasons relied upon the U.S. District Court in California in dismissing the City of Oakland and San Francisco's lawsuit against the same oil company defendants.

That being said, I had a positive meeting yesterday with Marco Simons, Esquire of the EarthRights International Group, Matt Edling, Esquire, Vic Sher, Esquire, of Sher Edling, and Jorge Mursuli. Sher Edling have been able to successfully obtain 6 remands to state court in the cases filed and removed in California, and have yet to suffer any dismissals.

We can discuss in further detail upon your return and at your convenience.
