Matt – good seeing you last month. We recently filed PFAS cases on behalf of Vermont: a foam case and a non-foam case. Defendants have removed the foam case to federal court and it was transferred to the MDL; the non-foam remains in state court. The complaints are attached. (Note that our names are not on the complaints because our contract with the state had to go through additional layers of approval prior to filing). I anticipate we likely will be representing additional states in PFAS over the course of the coming months.

We would, of course, be honored to represent Connecticut in PFAS litigation and stand ready to help if AG Tong decides to proceed with outside counsel. Meantime, could you please send the names of the folks we met with? I did not get all the names while we were there and I would like to send folks a quick email thank you note, if somewhat belatedly.
