How are you feeling? Totally recovered? Hope so! And I'm sure last night's senate race outcome helped buoy the spirits.

Some questions for you when you get a minute, most pressing at the top:

1-the Union of Concerned Scientists and we are planning a joint event for the evening of Thursday Jan 25, on the science and liability of holding fossil fuel companies liable for climate damages. (This was a suggestion of Ted's and we have been following up, and it's coming together really nicely.) Event will be 6pm-8pm or so at the Fowler. We are inviting a keynote speaker; not sure if we will get one—invitations are out to Becerra and to Garcetti, and we may ask Ted Lieu next. Then Peter Frumhoff of UCS will give a 15-minute overview of the science of attributing particular harms to particular companies. We'd then like someone from UCLA to give a parallel 15-minute talk about the basics of the law behind of these liability suits. Would you like to do that? I know you have been working with the group strategizing around some of these cases.

Those two opening talks will be followed by a conversation among a diverse set of people onstage, including Peter; whoever the law person is; Alex Hall; Serge Dedina, mayor of Imperial Beach; and probably one or two others TBD to bring different (but generally supportive) perspectives. Then Ken Kimmell of UCS will wrap up the evening with thoughts.

What do you say?

2-did you see Alex Jackson's email about the emissions market advisory group appointment? Just flagging it for you.

3-the UC carbon neutrality Pritzker brief is still in your court for comments/approval. (Let me know if something has gone horribly wrong with it and you haven't had time to figure out how to tell me yet!)

4-let's figure out a process for next steps on the Dan ask. Should you, Sean, Ted and I talk by phone? Happy to set that up.
