Submit Public Comment on The Biden Administration's Proposed Asylum Ban by *Today, March 27th*

In late February, the Department of Homeland Security and the Office for Immigration Review, Justice Department proposed a rule change that would, in effect, impose an Asylum ban, like the one President Trump imposed during his term. This new rule, by placing new restrictions on the asylum process, will effectively make it impossible for most people to seek asylum in the U.S. Those seeking asylum will be presumed ineligible unless:

- They schedule a time and place to appear at the border to request asylum by using CBP One App. This requires access to a digital device as well as the means to reach the border at the assigned time.
- Apply for two-year humanitarian parole, but only if applicants are from certain designated countries. And – they must fly to the U.S. at their own expense, have a valid passport, and have a sponsor who will support them financially. Even if parole is granted, though, it is temporary and does not offer a pathway to citizenship.
- They must have first applied for asylum in a country through which they have traveled.

Any person seeking asylum who is unable to meet one of those conditions will be *expelled* from the U.S. *without* due process. While Trump-era Asylum Ban was deemed illegal by a Federal Judge in the District of Columbia, this rule change also interferes with the internationally recognized right to seek asylum.

Robert Jackson, NY State Senator, 31st Senate District

- Senator Jackson is Chair of Civil Service and Pensions.
- Democrat & Working Families Party
- Senator Robert Jackson has taken on difficult fights on behalf of New Yorkers and never backed down: in his first elected position as School Board President where he launched the Campaign for Fiscal Equity school funding lawsuit, walked 150 miles to Albany to highlight the cause, and won a court judgment that awarded \$16 billion for NYC public schools; in his 12 years on the City Council where he sponsored the Small Business Jobs Survival Act and fought for justice and equality; and now as a State Senator championing public education, workers rights, climate justice, gun safety, and more. He knows how to get things done and has a record to prove it.
- Growing up in Northern Manhattan with eight brothers and sisters, times were often tough. As a student at PS 186, he never dreamed that one day he would be a New York State Senator. It was possible through hard work, perseverance, and the help of good people in the community. Teachers like his track coach at Benjamin Franklin High School, Irwin Goldberg, always played an important role. Mr. Goldberg pointed him in the right direction, making sure he went to college, and that has made all the difference. That's why Senator Jackson has fought so hard to knock down barriers and to make sure every child receives the best education possible.
- As a Community School Board President, Robert Jackson filed a lawsuit against New York State to fix an inequitable school funding distribution formula that was cheating schools and undermining our children's future. He walked 150 miles to Albany to bring attention to the lawsuit and won a court judgment that awarded \$16 billion for NYC schools. As a result of this landmark decision and "for being a staunch advocate for generations of New York City children, for never giving up on the belief that education is a basic civil right, and for giving millions of city students a fighting chance," NY1 honored Robert as "New Yorker of the Year".

- In 2001, Robert Jackson was elected to the City Council—and was twice overwhelmingly re-elected by the voters of his upper Manhattan district. Because of his experience, commitment and leadership, he was chosen to Chair the Education Committee and Co-Chair the Black, Latino, and Asian Caucus. On the City Council, Robert worked to make sure every child got the best education we have to offer by helping to create more than 4,000 new openings for pre-K, fought to prevent thousands of teacher layoffs, and helped start the Drop-Out Prevention Initiative. He worked to increase jobs and opportunities by sponsoring a landmark NYC MWBE law and the Small Business and Jobs Survival Act, and he helped create a community people-power training program cited as a national model by the Clinton Global Initiative. He passed increased immigrant services, was an early advocate for marriage equality, and a leader in combating bullying. He fought for smart budget choices that kept senior centers, libraries and fire stations open. And he worked to make our neighborhoods safer by getting guns off the street through partnering with community groups, sponsoring Buy Back Programs, and advocating for stronger state and federal legislation.
- In 2015, Jackson was elected District Leader and help found the new, progressive, grassroots Democratic Club, Uptown Community Democrats. Born and raised in Manhattan, Robert and his family have lived in Washington Heights since 1975. He attended New York City public schools and graduated from State University of New York at New Paltz. He is married and a dedicated father of three daughters.

 - Participants from the ICJ program presented their policy recommendations to DA Bragg, DOC Commissioner and audience. Certificates were conferred and a special tribute was given in memory of a participant who lost his life to gun violence shortly after his release.
Some of the recommendations included guidelines for work release, second chance sentences, and a proposal to create a condensed version of the ICJ course through Legal Training at DANY. This would be for rookie ADAs and inmates who may not normally choose to take part in the program.

- **Uptown Youth Collective Meeting | 02.09.23**
Number of Community Attendees: ~ 20, (Brian, Imani)
 - During the meeting the group reintroduced their rapid referral system that will seek to provide warm referrals to youth in need of services. The group listened to feedback from the youth and community-based organizations to make the necessary tweaks needed to be effective. One of the chair members also shared information about their upcoming youth council and explained to the youth in the room the history of teens being civically engaged and why it's important. The group also informed the audience that they have been in discussion with DANY regarding their violence prevention initiative and look forward to meeting with DA Bragg on February 17th. Lastly, a member of the steering committee proposed an idea to host an event centered around bringing the community together to understand the issues that are going on within the community and work towards solving the problem. Imani mentioned that our High School Internship program is now opened to apply and provided flyers to the group to share with the public.

- **CAPS Coalition Meeting with DA | 02.10.23**
Number of Community Attendees: 9 (DA Bragg, Jordan, Shawn, Mike, Estelle)
 - Group provided verbal and written list of concerns regarding shoplifting. DA Bragg and team shared the Office's retail theft strategy and focus on addressing Discovery requirements/capacity issues

Lower East Side/Lower Manhattan: (2)

- **Community Board 3 Social Services Providers Meeting | 02.06.2023**
Number of Attendees: 15 (Kevin)
 - Community Board 3 holds a quarterly meeting to organize the social services providers that service SDR and Tompkins Square Park. The providers all expressed that they have limitations with outreach to street homeless due to capacity. Kevin announced the office's RFP to provide funding to social service providers to increase their ability to conduct outreach to mentally ill, homeless, and substance addicted people. Tompkins Square Park has seen an inexplicable significant decrease in people in the park from roughly 30-35 a day to around 5 or less. SDR park continues to have a high number of K2 selling and people shooting up at the park. The Parks Department conducts needle

sweeps each morning in the playground to ensure it is clean and safe for children. They are concerned that people break into the park at night to use substances. Lastly, Henry Street and Hamilton Madison House have established their new CONNECT programs which sends outreach workers to connect with street homeless and mentally ill people in the community to connect them to their organizations.

- **Community Board 2 District Service Cabinet Meeting | 02.09.2023**

Number of Attendees: 20 (Kevin)

- Kevin attended this meeting and shared the Community Navigators RFP. The 6th Precinct shared that their crime numbers are up 30% week to date primarily due to grand larcenies from unattended property and commercial burglaries overnight. - **SNL Site Visits— Johnson Community Center | 02.04.23**

Number of Community Attendees ~ 20 (Brian)

- Brian visited the Johnson Community Center run by Scan Harbor in East Harlem. During the visit, Brian talked to the program manager to see how the program is doing, and he mentioned that on average they see 10- 15 youth per session. On this evening, the coach wasn't there to facilitate sessions, so the youth were engaging in free play. Brian asked about officers' engagement and the program manager shared that some officers are better than others, but they are happy to have them around. Brian mentioned DANY's high school internship and will and the program manager asked Brian to send him the information so he can promote it within the center and in Wagner houses. Brian sent the information over within the week and will look to follow-up with him next week.

- **District 4 Community Education Council Meeting | 02.08.23**
Number of Community Attendees: ~60 (Imani)
 - Imani attended CEC 4's monthly meeting. Topics discussed in the meeting addressed some of the parents' concerns about petitions to open more charter schools in district four, plans to remove the Young Women's Leadership School from DOE district 4, and discussions about budgeting for school renovations in the district. Imani shared information about the launch of the HSIP application. There were no questions about the internship or public safety.
- **Not Another Child Inc and DANY Meeting | 02.08.23**
Number of Community Attendees: 4 (Estelle, Kevin, and Marco)
 - CPU with the Founder of Not Another Child, Oresa Napper Williams, and Justin to learn more about the organization and its operations. CPU provided an overview of their work to Ms. Williams and discussed potential collaborations. Some topics uplifted throughout the meeting were youth engagement to prevent gun violence and potential SNL collaborations.
Next Steps: Connect the group with Giselle and Brian for GVP and SNL; DA potentially tour their office; Estelle will connect the group with DYCD.
- **Community Board 11 Public Safety and Transportation Meeting | 02.09.23**
Number of Community Attendees: 40 (Marco)
 - Marco shared information about the 9 million Dollar RFP for Neighborhood Navigators to address Mental Health and Substance Abuse, the new Mayoral partnership to address illegal cannabis sales, and DANY's High School Summer Internship Program. The information was well received.

West/Central Harlem: (3)

- **SNL Site Visit- Hansbrough Recreation Center | 02.04.23**
Number of Community Attendees ~20, CPU: Brian
 - Brian visited the Hansbrough Recreation Center SNL Program run by NYC Parks in Central Harlem. During Brian's visit, he talked to both the lead coach and the program manager to discuss how the program is doing. Both mentioned that the location was unusually cold, and they were contemplating ending program early if there is a low turnout. The youth kept coming so they decided to continue to host programming and just had them play organized scrimmages to keep them moving to keep warm. The lead coach used to work in SNL before for Lab Out Skillz so he mentioned that traditionally they have the youth do two hours of drills and then two hours of organized competitive play like they did it at Lab Out. He also mentioned that the program is looking to host events for the youth to replicate the NBA All-Star Weekend since the NBA event is scheduled to occur next week.
- **28 Precinct Community Council Meeting | 02.09.23**
Number of Community Attendees: 75 (DA Bragg, Courtney)
 - This meeting was well attended. No major issues for our office arose. DA Bragg was well received by the leadership and attendees as he presented encouraging statistics on crime in the area. A group of TAG student attended. One raised the importance of treating mental health issues as a component of reducing violence. DA Bragg asked the

Harlem Director to introduce himself and speak on how DANY is looking forward to working with young people, like TAG, to solve issues related to safety and crime.

- **PSA 6 Community Council Meeting | 02.09.23**

Number of Community Attendees: 60 (Courtney)

- This meeting was well attended. It was led by the council's president, Diana Blackwell. There were no major issues of concern. One emerging issue, brought to light by Captain O'Hanlon, is the use of drill rap to instigate beefs and target other for killing. Our office should keep an eye on this disturbing trend and be prepared to address it in the future if necessary.
Information on HSIP and the Navigator's' RFP was distributed. Both were well received. Flyers were left.

Number of Community Attendees: 20 law students (Chief Jeanine Launay, Senior Advisor Aparicio) |
- **NY Presbyterian Hospital Domestic & Other Violence Emergencies (DOVE) Victim Advocate DV Training | 02.07.23**
Number of Community Attendees: 40 (ADA Phillips) |
- **Teen DV Presentation at Urban Assembly School of Business for Young Women | 02.07.23**
Number of Community Attendees: 20 (ADA Dunigan, Omar Cyrille)
 - ADA Dunigan and Omar shared the Teen Dating Violence scenario with the students which covers how students can identify cycles of abuse and resources for survivors. The students did not ask questions about the scenarios but wanted to know more about what ADA Dunigan does in her day-to-day work and the average salary of an ADA. We are working with the school to schedule an Internet Safety/Cyberbullying presentation for the students.
- **Elder Abuse/Elder Scam Presentation at Mott Street Senior Center | 02.07.23**
Number of Community Attendees 50 (Chief Launay)
 - Chief Launay presented on common scams that target older adults. Some of the audience members expressed their skepticism about these scams influencing New Yorkers. Others shared their experiences hearing about these scams and how they've avoided becoming a victim. There were no questions about the presentation.
- **Teen Dating Violence at Millennium High School |02.08.23**
Number of Community Attendees: 30 (Deputy Chief Pennington)

- Deputy Chief Hannah Pennington and Kelsey Gallagher spoke with students about red flags and abusive behavior in dating. The students read through the scenario, and some share how they would react if they were in a similar situation. The students did not have many questions about how the office handles these cases but engaged with the material.

- **Teen Dating Violence at High School for Climate Justice | 02.10.23**
